- Full-time employment performing the duties of a regularly employed truck driver with a TTA member company. (Hostlers, casual drivers and persons whose driving is a secondary responsibility to other duties are not qualified.)
- Companies will be limited to three (3) drivers per class, per terminal.
- 2024 NTDC / NSVDC, drivers who have been in a non-preventable accident are now eligible to compete. The description of what is permitted and the process in which accident eligibility should be reviewed here along with the 2024 Eligibility Request Form.

STEP VAN CLASS

Step Van Class entries will be limited and is an <u>open</u> division. The winner will go on to represent TN at the ATA National Step Van Driving Championships which will be held in conjunction with the ATA National Truck Driving Championships. Step Van is a separate national competition and not a class of the NTDC.
